Before me this date personally appeared WILEY, MICHAEL D. (11836) who being first duly sworn deposes and says that on 27 day of May, (year) 2014 at 555 SE 1ST AV, FORT LAUDERDALE, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

driver of the vehicle that was involved in the crash. Lieutenant Akers asked that I respond to conducted an independent investigation.

At approximately 8:43 am, I arrived at the incident location. I met with BSO Sergeant Alphonso Bonaby (CCN#5160). Sergeant Bonaby advised of the information learned up to that time and explained BSO Deputy Manfreth Neilly (CCN#6370) and Deputy Robert Segedi (CCN#5520) had observed the driver, later identified as Lynn Feig by her Florida driver license, operating the vehicle. The driver is also known to this affiant as Lynn Rosenthal.

I met with Deputy Neilly who explained he first observed the black utility vehicle enter the parking area near the BSO Main Jail traveling at a speed greater than the posted five (5) miles per hour posted limit. Deputy Neilly advised as the black utility vehicle conducted the left turn towards the judicial parking area, the passenger side front of the SUV collided with the driver side rear bumper of the parked patrol vehicle. Deputy Neilly said the utility vehicle continued towards the judicial parking lot and collided with the security gate to the parking lot. Deputy Neilly advised the vehicle reversed and struck the gate several more times before he was able to make contact with the driver.

I also met with BSO Deputy Segedi who advised he had observed Feig operating the vehicle. Deputy Segedi stated that once Ms. Feig had stopped and after exiting her vehicle she appeared unsteady on her feet, her speech was slurred and she had difficulty obtaining the required documents. When asked, Deputy Segedi advised he did not detect an odor of an alcoholic beverage.

Probable Cause Affidavit

Before me this date personally appeared WILEY, MICHAEL D. (11836) who being first duly sworn deposes and says that on 27 day of May, (year) 2014 at 555 SE 1ST AV, FORT LAUDERDALE, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:


I conducted a brief inspection of the vehicles. I noted black paint transfer on the driver side rear bumper of the patrol vehicle. A tire mark was observed on the roadway behind the patrol vehicle that arced towards the final rest of the black utility vehicle. I observed white paint transfer on the passenger side front bumper of the utility vehicle. The physical evidence observed on scene was consistent with the information obtained to that point. While conducting my vehicle inspection, I observed fresh damage to the driver side rear rim and fender, I also observed damage to the driver side front rim and tire. The damage observed on the driver side of the utility vehicle, although recent, did not appear to be related to the crash involving the parked patrol vehicle.

I made contact with Lynn Feig who was standing near the driver side door of her vehicle. I introduced myself and advised her I had been requested to respond to conduct a DUI investigation. Ms. Feig immediately advised she had not consumed any alcohol for a very long time. While speaking with Ms. Feig I did not detect any odors consistent with the consumption of alcohol. I did observed she appeared unsteady on her feet and noted her speech seemed slow and mumbled.

I asked Ms. Feig if she required any medical assistance or had been injured in the crash. Ms. Feig explained she was not injured from the crash with the patrol vehicle or the crash from earlier in the morning. When asked about the "other" crash, Ms. Feig advised she had been involved in an incident on I-595 with another vehicle. Ms. Feig explained a truck had attempted to run her off of the road and she had captured the incident on her cell phone. Ms. Feig then obtained her cell phone and proceeded to

(11836) who being first duly sworn deposes and says that on 27 day of May, (year) 2014 at 555 SE 1ST AV, FORT LAUDERDALE, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

show me a video of her vehicle driving on what appeared to be eastbound I-595. The video displayed Ms. Feig's utility vehicle drifting between lanes and over the solid yellow lane line in to the breakdown lane. At one point the video showed Feig's vehicle collide with the concrete barrier wall. The information learned from the video was consistent with the damage on the driver side of the utility vehicle. At no point in the video did I observe a truck or any other vehicle drive in a manner that would have influenced her path of travel. The video did display that Ms. Feig was unable to maintain a single lane, drove in the breakdown lane and failed to avoid a collision with a concrete wall.

I asked Ms. Feig if she would be willing to conduct the Standardized Field Sobriety Exercises (SFSE's), to which she agreed. Ms. Feig advised she was not injured, did not suffer from any illnesses and that she had taken prescription sleeping medication the previous night. When specifically asked about the prescription medication she stated she last took Ambien CR at approximately 10:00 pm (Monday).

The following exercises were conducted in the parking lot of the BSO Main Jail. The area used was a flat, dry, black top surface free from debris. A yellow parking line was used to conduct the Walk and Turn exercise.

HGN:0 Clues

Pupils appeared to be equal size and both eyes tracked together.

Walk and Turn: 4 Clues

Failed to maintain balance during instructions.

Based upon the performance of the exercises, it was this investigators opinion Ms. Feig was under the influence of a chemical and/or a controlled substance to the extent that her normal faculties were impaired. While conducting the exercises, Fort Lauderdale Fire/Rescue Unit #2 arrived on scene. As a precaution, paramedics conducted an examination and determined she had not sustained any injuries and her blood pressure was normal. The paramedics also completed a test to determine the blood sugar level which tested within normal tolerance.

At approximately 9:35 am, Lynn Feig was taken in to custody for DUI and transported to the Breath Alcohol Testing (BAT) facility. Community Service Aide (CSA) Lani Eckinger (CCN#4465) placed Ms. Feig on video for court presentation. I requested Ms. Feig submit to a breath, urine and blood test to determine the presence of any chemical or controlled substances. Ms. Feig agreed to submit to the breath test only. She was advised of the consequences of refusing (Florida Implied Consent) and again refused to submit to a urine and blood test. CSA Eckinger completed the breath test with results of .000/.000.
