Re: Nomination of Citizen Member to the Board of the South Florida Regional Transportation Authority

Dear Ms. Coffey and Ms. Henry:

This firm represents James Cummings in connection with the concerns that your office has been previously made aware of regarding the failure of Broward County (the "County") to follow the "At-Large Board Rotation Procedures" established and adopted by the Broward County Commission (the "Commission") on May 15, 2001, as amended (the "Procedures").

We understand the County believes Mr. Cummings most recent term as the citizen member of the Board of South Florida Regional Transportation Authority ("SFRTA") under Florida Statute §343.53(2)(b) expired on August 30, 2015 due to Mr. Cummings' nomination for such term being approved on August 30, 2011 (see enclosed email from Eddy Labrador, Director Office of Intergovernmental Affairs and Professional Standards dated August 19, 2015); please note Mr. Cummings late nomination for reappointment by former Commissioner Jacobs resulted in such approval being August 30, 2011. Mr. Cummings desires to be considered for reappointment as the citizen member of the Board of the SFRTA, and as detailed below, we respectfully disagree and believe it is clear Mr. Cummings' term expired on July 30, 2015. The consequence of the different expiration dates materially and adversely affected the Procedures of the Commission to

the detriment of Mr. Cummings and his desire to be considered for reappointment as the citizen member of the Board of the SFRTA.

As you may be aware, Mr. Cummings has served on the Board of the SFRTA for the past eighteen (18) years, including in the capacity as Chairman and Vice Chairman. Mr. Cummings was a member of the Board of the Tri-County Rail Authority prior to its redesignation as the SFRTA in 2003. Following such redesignation, Mr. Cummings continued as the County's citizen member of the Board of the SFRTA and was reappointed by the Commission in 2007 and 2011.

In connection with such redesignation, the term of Mr. Cummings' appointment to the Board of the SFRTA began on July 30, 2003. Specifically, §343.53(3)(b) of the Florida Statutes effective at such time provided: "The terms of the board members currently serving on the authority that is being succeeded by this act shall expire July 30, 2003, at which time the terms of the members appointed pursuant to subsection (2) shall commence." Following Mr. Cummings' first appointment following such redesignation, the expiration date of such term was July 30, 2007 and following Mr. Cummings' reappointment the expiration date of such term was July 30, 2011.

The County believes that because Mr. Cummings' nomination for his second reappointment term was approved on August 30, 2011, the expiration date of such term is August 30, 2015. As of July 30, 2011, the expiration date of Mr. Cummings' first reappointment term, there was a vacancy for the County's citizen member of the Board of the SFRTA. This vacancy was subsequently remedied following Mr. Cummings reappointment on August 30, 2011. §343.53(4) of the Florida Statutes provides that in the event of any vacancy any appointment to the Board of the SFRTA is only for the "balance of the unexpired term." As §343.53(3)(b) of the Florida Statutes effective at such time set the terms to commence on July 30, 2003, the term of membership to the Board is four (4) years pursuant to §343.53(3) of the Florida Statutes and §343.53(4) of the Florida Statutes requires appointments only for the "balance of the unexpired term" in the event of any vacancy, it is clear the term of Mr. Cummings' reappointment in 2011 expired on July 30, 2015.

It is important to also note the County's website for the SFRTA tracks the language from §343.53(3)(b) of the Florida Statutes before the amendments thereto in 2012 and also includes the same language from §343.53(4) of the Florida Statutes. In addition, on this same website page it references that the County's website was updated on January 21, 2015. We also understand that the term of the citizen members of the Board of the SFRTA for the Counties of Miami-Dade and Palm Beach expired on July 31, 2015 and the term for the reappointments thereunder will continue until July 31, 2019. It seems clear beyond peradventure that Mr. Cummings' term expired on July 30, 2015.

Accordingly, we believe the County erroneously determined the expiration date of Mr. Cummings most recent reappointment term as a member of the Board of SFRTA to expire on or about August 31, 2015 as opposed to the date established by law as July 30, 2015. This error resulted in the term expiration of the County's citizen member of the Board of the SFRTA not being properly, timely or lawfully placed on the "list of vacancies or term expirations" compiled

by County staff and provided to the appropriate Commissioner on the "rotation list" in compliance with the Procedures.

Due to the County's failure to follow the law and the Procedures, we respectfully request that the County withdraw the motion to nominate Beth Talabisco to the Board of the SFRTA currently on the agenda for the Commission's regular meeting scheduled for August 25, 2015. In addition, it only seems fair and equitable the appointment of the citizen member of the Board of the SFRTA immediately be added to the current "list of vacancies or term expirations" recently given to Commissioner Ryan who is next in the rotation (per the enclosed email from Eddy Labrador, Director Office of Intergovernmental Affairs and Professional Standards dated August 19, 2015) after Commissioner Ritter and in accordance with the Procedures to be concluded in a timely manner before the Commission's next regularly scheduled meeting September 1, 2015.

To the extent, the County does not withdraw such motion as requested, Mr. Cummings reserves all rights and remedies in connection with the County's failure to follow the law and the Procedures.
